As per the Government Order referred 1 & 2, the Pravasi Legal Aid Cell (PLAC) was established to provide legal assistance and advice to distressed NRKs facing legal issues with passports, visas, employment, social matters, and legal cases, particularly for those imprisoned in Gulf Cooperation Council (GCC) countries without willful default. The cell also conducts legal awareness programs, offers translation help, and collaborates with Malayalee Cultural Organizations to support distressed NRKs. Many Keralites, unfamiliar with the laws, procedures, culture, and language of their host countries, are vulnerable to exploitation by unscrupulous middlemen and employers, often ending up as illegal migrants by taking jobs without proper documentation or overstaying their visas. Without legal assistance, these workers frequently face imprisonment and severe mistreatment, which PLAC aims to mitigate by providing necessary legal help.

Vide Government order referred 2<sup>nd</sup> above guidelines were issued to engage Legal Liaison Officers under Pravasi Legal Assistance Scheme and vide reference 3<sup>rd</sup> cited Government changed the designation of 'Legal Liaison Officer' to 'Norka Legal Consultant'. In the aforementioned order, referred as 2<sup>nd</sup> cited interalia, constituted the Selection Committee for the selection of NORKA Legal Consultants, and the Chief Executive Officer, NORKA-ROOTS was authorized to execute agreements with the selected NLC's. As such eleven NORKA Legal Consultants was engaged in six countries under Pravasi Legal assistance Scheme for a period of 2 years. Later, the tenure of engagement was further extended until the selection and empanelment of new NORKA Legal Consultants.

Following this, notifications inviting applications for NORKA Legal Consultants were issued. The Selection Committee prepared the list of candidates based on their biodata, achievements, guidelines

parameters, and interview performance, as detailed in the 4<sup>th</sup> and 5<sup>th</sup> of the references cited and approved the list of NORKA Legal Consultants under Pravasi Legal Aid Cell as listed below.

In the above circumstances, the following candidates are selected as Norka Legal Consultant for the country/place noted against each of them for a period of two years as per the terms and conditions prescribed in the Government Order referred as 2<sup>nd</sup> paper above
