 - Diploma in General Nursing & Midwifery (GNM):Registered Nurse / Midwifery
 - Bachelor of Science in Nursing and Midwifery (Basic): Registered Nurse / Midwife
 - b. Have an Indian Nurse / Midwife Registration Certificate;
 - c. Legal age of 18 years;
- 2. Proof of a language level of at least:
 - a. IELTS Listening, Reading, Speaking 7.0 in each section / Writing 6.5 OR
 - b. OET Listening, Reading, Speaking B in each section / Writing C+

Mandatory Requirements:

Nurses - at least 1 year acute hospital experience or mental health nursing experience,

worked within the last 3 years.

Midwives - newly qualified midwife (qualified within the last 2 years, but with no experience) or at least 1 year midwife experience worked within the last 3 years.

Post selection process:

The selected candidates after arriving in the UK have to pass OSCE test for acquiring professional licence. The Yeovil District Hospital NHS Trust with assistance of the employer will provide OSCE training to support the candidate with the final step of the NMC recognition assessment (OSCE Test) to ensure as best as possible that employment as a UK registered nurse can actually be obtained. It may be noted that the failure to pass OSCE within 8 months will result in the visa and employment contract being terminated.

Upon employment and whilst training for OSCE, the candidate will be paid top of Band 4 pay scale £24,882* (Annually)

Upon successfully passing OSCE and gaining their NMC registration the candidate will receive the full Band 5 Nursing salary £25,655 - £31,534* (depending on relevant experience)

Yeovil District Hospital NHS Trust will refund £250 towards Visa fee to the candidates and a maximum of $\,\pounds\,600$ will be provided towards the airplane ticket charge from India to the UK.
