- 5. NPRI Certificate
- 6. Passport copy
- 7. Bank Passbook.
- 8. In case of death which has occurred due to Critical Illness after waiting period (30 days after the date of issue of the certificate) of the policy please provide the death certificate as well as legal heirship certificate and details of nominee
